Pursuant to art. 12 of Reg. 2016/679, regarding the protection of personal data, we inform you that your data will be:

- processed lawfully and fairly;
- processed for specific, explicit and legitimate purposes;
- accurate and updated;
- relevant and complete;
- kept only for the period of time necessary to achieve the purposes referred to in the following point a).

We also inform you that (see Article 12 of the aforementioned Regulation):

- a) purpose of the processing: the data will be processed for providing the service of the contract, the management of invoices, the purposes related to the obligations provided for by law;
- b) communication and dissemination of data: in relation to the pursuit of the aforementioned purposes, your data may be transmitted, as well as to people authorized by the owner to perform processing operations, to third parties for the performance of the activities listed above and responsible for the treatment of accounting and legal assistance of the data controller;
- c) Extra EC Transfer: The data controller does not intend to transfer personal data to a third country or to an international organization;
- d) Data retention period: Data retention is necessary for the whole period in which the contractual relationship and the subsequent period imposed by the EU and Italian State rules will remain valid. Except for these conditions, the data owner reserves the right to keep the data for a period of one year beyond what is already indicated;
- e) Processing of particular categories of data: We invite you not to insert particular categories of data (sensitive data), suitable for revealing racial and ethnic origin, religious, philosophical or other beliefs, political opinions, membership to parties, labor unions, associations or organizations of religious, philosophical, political or labor union nature, as well as personal data suitable for revealing the state of health and sexual life;
- f) Conferment: the conferment of all the requested data is mandatory in relation to the proceeding of the supply foreseen by the contract;
- g) Automated decision making process: The data controller informs the data subject that there is no automated decision-making process, including profiling pursuant to article 22 of the EU Reg 2016/679;
- h) Data controller: **BULGARI AGOSTONO S.r.l.** – Via Brescia, 30 – 25020 Pavone del Mella (BS). In the person of the Legal Representative of the company;
- i) Responsible for processing: the person in charge of data processing is Mr. Bulgari Roberto. Therefore, you can apply directly to assert your rights, as provided for in Chapter III (articles 15 to 22) of EU Reg. 2016/679.

We remind you that, according to Chapter III (articles 15 to 22) of the aforementioned Regulation, you have the right at any time to obtain confirmation of the existence or not of the same data and to know its content and origin, verify accuracy or request integration or updating, or rectification, limitation, portability, opposition.

According to the same article, you have the right to request cancellation, transformation into anonymous form or blocking of data processed in violation of the law, as well as to oppose in any case, for legitimate reasons, to their treatment.
